**Schedule of Rates and Charges**

1. Metered Rates Per Month

- a. For use of and service rendered by the waterworks system of the Watson Rural Water Company based on the use of water supplied by said waterworks system:

First 5,000 gallons	\$	6.55
Next 15,000 gallons	\$	5.30
Over 20,000 gallons	\$	4.00

b. Temporary Users

Water furnished to temporary users such as contractors shall be charged on the basis of the metered rates herein set forth and the number of gallons shall be estimated and/or established by the Water Company with rented hydrant meter.

c. Minimum Charge Per Month

Each member shall pay a minimum charge in accordance with the following applicable size of meter installed, for which the member will be entitled to the quantity of water set out in the above metered block rates.

2. Connection Charges

- a. Each applicant for a 5/8 inch meter shall pay a tap charge of \$1,000 to cover the cost of excavating and tapping the main; furnishing and installing service pipe from the main to the meter location; furnishing and installing corporation stops; and furnishing and installing meter pit (if outside), setter and Radio Read meter.

b. Each applicant for all other meter sizes shall pay the actual cost of labor, materials, power machinery, transportation and overhead incurred for installing the tap, but shall not be less than the charge of a 5/8 inch meter tap.

c. In addition to the Tap fee, each applicant shall pay System Development Fee

d. Added to the fees charged in (a) or (b) and (c) above shall be the actual cost of all state and county permits.

3. Membership Fee \$ 100.00

A membership fee of \$100 shall be paid in addition to the connection charge, upon application for the membership in this Water Company. The membership is refundable upon final payment of any arrears due to the Water Company.

4. Disconnect Late Penalty Fee \$ 40.00

Failure to pay within thirty days of the date that the bill is mailed will result in the member being scheduled for disconnection of service. In the event it becomes necessary for the Company to mail a disconnection notice to a Member for non-payment, a penalty of \$40.00 will be charged if payment is not received before the date of disconnection shown on the notice mailed to the member. This charge, together with any arrears due, must be paid to continue water service to the location.

5. Disconnect Penalty \$ 40.00

When the service is turned off for nonpayment of bill or for any reason beyond the control of the Water Company a reestablishment of service is required by any member, this charge will be made by the Water Company for discontinuance and, if requested by the member, reestablishment of service. This charge, together with any arrears due, must be received to restore service.

6. General Service Charge \$ 35.00

This charge will be made for any trip to the members premises at their request for conditions on the members responsibility side of the meter.

7. Service Call - Turn On/Off \$ 50.00

This charge will be made for any trip to the members premises at their request for discontinuance of service. The Company will be responsible for discontinuing and reestablishing service to the member.

8. Return Check / Drafting Charge \$ 25.00

This charge will be made for each instance that a check or bank drafting issued in payment is returned to the Water Company by the depository bank, such check or drafting not having been honored by the bank for any reason.

9. Collection and Deferred Payment Charges

All bills for water services not paid within seventeen (17) days from the mailing date thereof, as stated in such bills, shall be subject to the collection or deferred payment charge of ten percent (10%) on the first \$3.00 and three percent (3%) on the excess over \$3.00.
